## **RE: Updated depreciation process**

Dear Collision Repair Facilities:

Back in June we updated the Material Damage procedures <u>depreciation process</u> to allow repair facilities to focus on continuing with timely repairs to vehicles without the need to discuss betterment related items with the customer.

We are now asking participants to identify depreciable parts that fall below the threshold of \$100, by attaching an explanation line to the part in question. Please note, you are not required to use the "<u>Requires Review</u>" process when submitting an estimate if there is no depreciation being applied.

We have attached the steps that need to be followed to add an explanation line in Mitchell. We require the exact wording to be used so please follow the attached instructions.

## ICBC Explanation Line Update – September 2021

This document provides step by step instructions to assist ICBC Repair Facilities with updating their ICBC Explanation Lines in Mitchell Ultramate.

Explanation Line Update - in support of ICBC Depreciation policy update

**Multi User** – In a multiuser environment, only one user can access this dialog box at a time. A prompt will display if the dialog box is in use. This step will need to be completed on all workstations.

**Single User** – Complete these steps on all systems with a single user setup.

## **Update ICBC Explanation Lines:**

1. Login to Mitchell Estimating with User ID: MITCHELL, Password: MITCHELL



- 2. From the menu bar, select System Info and click Explanation Lines.
- 3. In the Explanation Lines window, click New.
