Participants may receive the new ATS Hourly Rate when the estimate profile is updated for vehicle repairs in progress with a car-in date of January 1, 2025, or later. The ATS Hourly Rate may be applied by the Participant when a replacement vehicle is not provided up to May 1, 2025, then the flat \$100 Allowance rate must be used.
